



# Loanstreet X Yoodo Terms & Conditions

1. Loanstreet X Yoodo is a collaboration of Loanstreet's participating insurance partner and Yoodo is only facilitating the message on behalf of Loanstreet (Organiser). The Collaboration is governed by these terms and conditions, including any subsequent amendments thereto ("Terms & Conditions").
2. All leads from the collaboration will be deemed to have accepted the Terms & Conditions.
3. The Redemption of discount voucher is open to all who are:
  - i. Users of Yoodo Telco Services;
  - ii. are eighteen (18) years of age or above;
4. Finology reserves the right at any time to verify the eligibility of any of the Leads and to disqualify any who do not meet the above eligibility criteria.
5. Eligible submissions for the discount voucher will only be via the link provided in Yoodo's promotional collateral such as electronic direct mailer, In-App Deals, Microsite, & Social Post for this offer.

12. Each Discount Voucher will be applied on the User's Car Insurance
